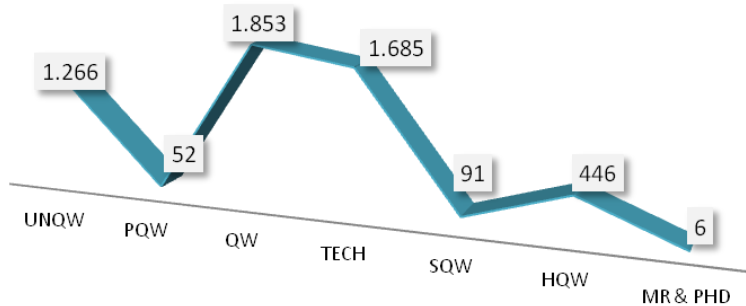
► Dominant areas of activity of companies in total income generated in 2022

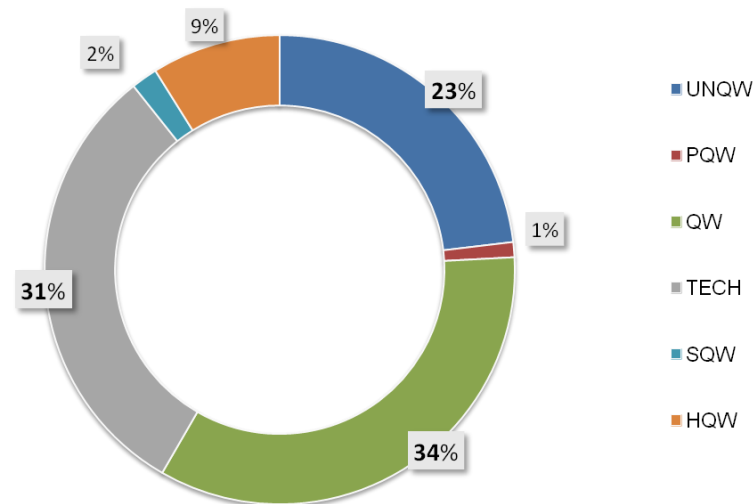
